Project: 4-WD Ambulance and related emergency equipment for Nagarkot Community Health Centre

Location: Jalpadevi Telkot, Nagarkot-1, Nepal

The municipality of Nagarkot is situated outside of Kathmandu Valley beyond the ridges bordering the valley. The very ridge is well known to many tourists of Nepal as a lot of hotels and tourist lodges are offering an easy accessible opportunity to see a major part of the Himalayan range especially at sun rise. But beside this, Nagarkot is a village area where life goes on like in most other parts of Nepal unnoticed that the capital of the country is so nearby, but the distance to the city centre is actually only 35 km.

In the year of 2005 a small Community Health Centre was established with the support of Rotary Club of Kathmandu with the support of Nagarkot VDC, Jalpadevi Community Forest Committee, some local elites of the area and Rotarians from Kathmandu and it has been expanded and supplied several times since then. In the same year, Nepal Bharat Maitri Samaj (Nepal India Friendship Society) through the Indian Embassy in Nepal donated a small ambulance to the clinic.

The clinic serves a population of around 7.500 in the VDCs of Bageswori, Chhaling, Baluwapati and





Naldum. Many ethnic groups are residing here, mainly Brahman, Chhetri and Tamang. Most of the people are solely depending on agriculture and vegetable farming. Very few sell their products to the markets in the capital, and most even have difficulties to produce enough for their own needs. Generally the educational level is very low and very few have received higher education. Knowledge about health is almost zero. Family size is 4,9 (national average is 4,4). Several families have experienced severe exploitation from enterprising Kathmandu citizens with the

result that many girls have been victims of trafficking to India, and venereal diseases are spreading faster than other places. This is the situation where this small Health Centre is trying to support the population with basic health care, but also to establish training and lectures for the population about health issues and human rights.

The Clinic is situated on the slope high above the valley. It has 3 stories with 9 rooms. On top there is a meeting hall where trainings and lectures are held. There is a lobby from which there is entrance for Consultation Rooms, Pharmacy, Dental Clinic, Observation Room, Store Rooms and clean Toilet facilities. The manpower running the clinic is a Director, two Nurses and an Office Assistant. A Doctor is visiting the clinic on monthly basis. The clinic is open 7 days a week from 8.00 hrs in the morning to 15.00 hrs in the afternoon.

As said earlier the clinic was donated a small ambulance by Nepal Bharat Maitri Samaj in 2005. As the clinic is mainly concentrating on basic health, the ambulance is mostly serving for transportation of local patients between the clinic and hospitals in Kathmandu. For that purpose it has served well, as the road that way is quite well constructed and most of the way with hard surface. But far the most of the catchment area for the clinic is up and behind the ridge, where only very poor roads are available where they exist at all. It has created many helpless situations where help should and could have been given, but the low clearance car as shown in the



picture with small wheels couldn't even get near the place where help was needed.

Therefore the clinic has such a great desire to shift the small ambulance with a Four-Wheel-Drive Ambulance. The existing ambulance will be donated to continue serving in another local community. Several options are already in question.

The 4-WD Ambulance which is so very much wanted by the staff of the Centre is a Tata Sumo from Tata Motors made in India. It will be delivered fully



equipped as an ambulance which has already proved its efficiency in rural parts of Nepal.

Cars imported to Nepal will usually be imposed with a quite high tax, but not with an ambulance which is duty free. Therefore the price fully equipped and delivered in Kathmandu will be as mentioned in the Budget below, unless Tata Motors announce changes in prices after this project proposal is completed.

Where the present ambulance is mainly serving the transfer of stabilized patients from the Clinic to a Hospital in Kathmandu, the new ambulance will lead to many more acute and emergency cases as it will serve a much wider area in the back country. But in that case the Clinic needs to be upgraded with Emergency Equipments, which is therefore added as a necessary supplement to the Ambulance Project.

Rotary Club of Kathmandu as well as the Clinic and Community in Nagarkot is already in the project with guarantee fund. They now need an International cooperating Rotary Club to support the project, but also to open up for a Rotary International Matching Grant.

Kurt Lomborg and Thøger Berg Nielsen from Skivehus Rotary Klub know the Nagarkot Community Health Centre very well as well as they are familiar with Rotary Club of Kathmandu and with the conditions in Nepal in general, and Kurt visits Nepal at least once a year and will also monitor this project soon after its implementation. Therefore it will be suggested that the project is run under the host responsibility of Rotary Club of Kathmandu and international responsibility by Skivehus Rotary Klub with economic support from Løgstør Rotary Klub and Copenhagen International Rotary Klub.
